# FROM THE FOUNDERS

“Of those men who have overturned the liberties of republics, the greatest number have begun their career by paying an obsequious court to the people; commencing demagogues, and ending tyrants.” Alexander Hamilton, [Federalist #1](#)

In Federalist #1, Hamilton attempted to warn the citizens of New York of the demagoguery of the anti-Federalists. While Hamilton’s warnings bared some reasonableness, his criticisms were a bit demagogic on their own.
