

FROM THE FOUNDERS



Defenders of ObamaCare will make the case that health care is a natural right. Some even quote Thomas Jefferson to defend their case. As is usually the case with our Founding Fathers, Jefferson's belief on health is taken out of context.

"Be good, be learned, and be industrious, and you will not want the aid of travelling to render you precious to your country, dear to your friends, happy within yourself. I repeat my advice to take a great deal of exercise, and on foot. Health is the first requisite after morality." Thomas Jefferson, <u>Letter</u> to Peter Carr, August 10, 1787

Families USA describes itself as "The Voice for Health Care Consumers." What they are is an advocacy for mandatory health care enrollment. In a blog <u>post</u> dated November 15, 2010, they attempt to make the case that Thomas Jefferson "would be nothing short of proud of our progress" as it relates to the national oversight and regulation of health care. While it is true that Jefferson believed that health care should be as safe as possible and that bad medical facilities should be made to improve or closed if they failed to, it is a stretch to equate his concerns with tacit approval of a national health care system.

It must be remembered that Jefferson was a strong proponent of states' powers and individual responsibility. Jefferson was indeed a charitable and generous man. He was not a proponent of such charity and generosity being coerced by the government through excessive taxation. Those who could not provide for themselves should be aided by those who could. That is what the moral man does. It is biblical to help those who cannot help themselves. Those who will not, or put themselves in precarious positions from making poor life choices will learn and repent of such behavior.

Even so, emergency medical care is required by law. Hospitals cannot turn away those needing immediate medical attention cannot be turned away because of lack of ability to pay for such care. Jefferson would have approved of that, as I believe would have most Founders. The current and proposed system of national health care is not what the Founders envisioned for our republic. We have much better options.

Currently I am teaching a discipleship class titled "The Insanity of Obedience." Last week's topic was on persecution, which is primarily the main theme. I stated that America is not really facing persecution. One woman in the class rightly pointed out that some Christians have and are indeed facing persecution for refusing to provide services that violate their religious convictions. In his article, Pastor Phillips writes of Christian businesses and religious institutions who have for the last 3-4 years been fighting ObamaCare mandates that violate their religious liberty protected by the 1st Amendment.

The new health care plan being supported by President Trump and Speaker Paul Ryan does not do all that was promised. I have had an ongoing conversation with my new Republican Congressman Matt Gaetz. I appreciate Matt's direct responses to my questions, even if I don't necessarily like the answers.

I've come to the conclusion that I believe President Trump is setting up the Congressional Republican leaders, and not vice-versa as was my first concern. He is giving this "first step" as a way to put Senator McConnell and Speaker Ryan on record as to committing to going the distance on having a true market-based health care system that is available to all who desire to participate and provided to those who cannot afford it.

However, as Christians we cannot compromise our biblical values for the sake of political expediency. I am grateful that under President Trump's plan the Federal Government cannot provide taxpayer dollars to Planned Parenthood. The abolishment of that abominable organization is long past due. It is also good that those who enter our country illegally will not be allowed health care entitlements without checking their status first.

We are going to have to keep our eye on this health care "ball" and not allow this first step to become the only step. All the while, we must be committed to living "boldly according to God's Word." Never before has this been needed more.
