FROM THE FOUNDERS



It is time to teach Americans that the Supreme Court is not the ultimate authority on constitutional matters. They are merely one of three branches of government enumerated with powers to apply the Constitution.

“You seem ... to consider the judges as the ultimate arbiters of all constitutional questions; a very dangerous doctrine indeed, and one which would place us under the despotism of an oligarchy... The Constitution has erected no such single tribunal.” Thomas Jefferson, [Letter](#) to William C. Jarvis, September 28, 1820

The US Supreme Court is not the final law of the land. Article VI, Section 2 of the US Constitution states:

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

The US Constitution is but one of four sources of the [Organic Law](#) of the US Code, preceded by the [Declaration of Independence](#), the [Articles of Confederation](#), and the [Northwest Ordinance](#), respectively.

However, there is one law above any man-made law, and that is God’s law. In fact, the Declaration of Independence declares as much in the often overlooked first paragraph:

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them...
