



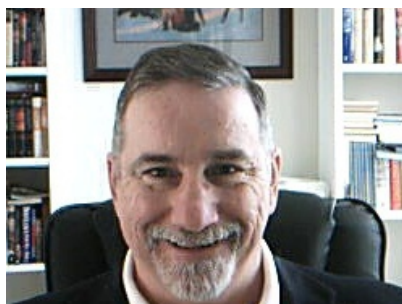

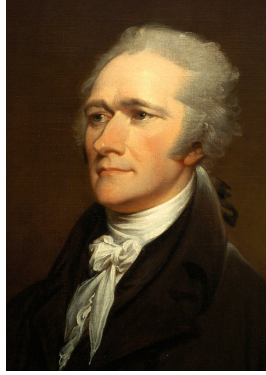
So it will be with homosexual marriage.

# FROM THE FOUNDERS



**Our Founding Fathers would have long ago impeached a good number of activist judges on our federal courts. They would have also publicly condemned any legislator, governor, or president who acquiesced to the lie of judicial supremacy.**

“Whoever attentively considers the different departments of power must perceive, that, in a government in which they are separated from each other, the judiciary, from the nature of its functions, will always be the least dangerous to the political rights of the Constitution; because it will be least in a capacity to annoy or injure them.” Alexander Hamilton, [Federalist #78](#).

Hamilton writes in [Federalist #81](#) that the judiciary has no real power because of “its comparative weakness, and from its total incapacity to support its usurpations by force.” So then why is our current Supreme Court seemingly so powerful? It is because the other two branches of government believe the Court has supremacy over their enumerated constitutional powers. And WE the People apparently agree with current and past congresses and presidents.

Many constitutional scholars and historians will point back to SCOTUS’ Marbury vs. Madison [ruling](#) as the basis for judicial supremacy, but they are wrong. While that case can be pointed to as the nexus for judicial review, then Chief Justice John Marshall acknowledged the court’s right to hear the petition, it did not have the power to force the executive branch to act on its findings.

Random House Dictionary defines *supreme* as “highest in rank or authority; paramount; sovereign; chief; of the highest quality, degree, character, importance.” There is no founding document that can defend that definition being applied to the judicial branch of our federal government.

In fact, the Supreme Judge is outlined in a document that inspired our founding. Turn the page to find out where.

# FROM THE PULPIT

“Let them know that this Jesus Christ, by whom peace is made between God and man, is Lord of all; not only as over all, God blessed for evermore, but as Mediator: All power, both in heaven and in earth, is put into His hand, and all judgment committed to Him...See what must be believed concerning Him; that we are all accountable to Christ as our Judge...” from “Matthew Henry Concise Commentary on the Whole Bible” concerning Acts 10:42.

Pastor Henry makes the biblical case that all humans are accountable to Jesus Christ as the Supreme Judge. No court of human design trumps the sovereign authority of Christ the King. No legislative ruling, executive order, or electorate outcome can overrule God’s word and reign.

The Bible teaches in Proverbs 14:34 that, “Righteousness exalts a nation, but sin is a reproach to any people.” The meaning of the word *any* should be clear to anyone and therefore removes any possibility of exemption for America as a nation.

History is strewn with once great nations taken down and thrown on the ash heap of extinction because of its rejection of God’s sovereignty. America was found on biblical principles, not that all citizens must be of the Christian faith, but that all would recognize that a nation such as ours, one self-governed through the rule of law, would be obedient to “the laws of nature and nature’s God.”

It is natural law that ensures the liberty and perpetuation of mankind. Life, liberty, and the pursuit of happiness are God-given unalienable rights. Blacks Law Dictionary [defines](#) natural law as:

*“A rule of conduct arising out of the natural relations of human beings, established by the Creator, and existing prior to any positive precept. The foundation of this law is placed by the best writers in the will of God, discovered by right reason, and aided by divine revelation; and its principles, when applicable, apply with equal obligation to individuals and nation.”*

It would stretch even the most depraved imagination to believe homosexual marriage would fit within the definition of natural law. Homosexuality defies natural relations and God the Creator. It cannot be discovered by right reason nor be aided by divine revelation.

Finally, homosexuality cannot be applied with equal obligation to individuals or a nation. It is antithetical to all that defines natural law.
